

MTN DEW YEAR OF GROCERIES FROM WEIS MARKETS 2020 TTW SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY. MESSAGE AND DATA RATES MAY APPLY. MULTIPLE ENTRY DEADLINES APPLY.

1. **SWEEPSTAKES PERIOD:** Sweepstakes begins at 12:00:00 a.m. Eastern Time (ET) on June 4, 2020 and ends at 11:59:59 p.m. ET on July 12, 2020 (“Sweepstakes Period”).
2. **HOW TO ENTER:** During the Sweepstakes Period, you can enter via the following methods: **(a) TEXT MESSAGE:** Use your mobile phone to text “**GROCERIES**” to short code **60763** and you will be automatically entered into the Sweepstakes. Participants must have a mobile phone with text messaging capabilities to enter by text message and may incur standard text message and data charges from their wireless service provider for each message sent and received. Approximately a total of three (3) text messages will be required to participate. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. By entering this Sweepstakes via text messaging the entrant is consenting to receive text and phone messages regarding the Sweepstakes. Entrants will be given the opportunity to “cancel” (or unsubscribe) each time they receive a text message by sending “STOP” to the short code above; **(b) INTERNET: To enter without sending a text message,** visit **www.goin2win.com/groceries** (the “Website”), and follow the on-screen instructions to properly complete and submit an online entry.

Limit one (1) entry per person, regardless of entry method, throughout the Sweepstakes Period. A “day” is defined as a twenty-four (24) hour time period beginning at 12:00:00 a.m. ET and ending at 11:59:59 p.m. ET. The time clock of the Sweepstakes administrator is the official clock for this Sweepstakes.

In the event of dispute over the identity of a potential winner, an online or text message entry will be declared made by the authorized account holder of such email address or wireless phone number submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such email address or wireless phone number. First Prizes: 40 (40) First Prizes will be awarded one (1) \$50 Weis Markets Gift Cards. ARV of each First Prize: \$50.

Total value of awarded prizes: \$8,000

Limit one (1) prize per name, address and/or household.

6. WINNER NOTIFICATION: Potential winners will be notified by text, phone and/or email at the phone number and/or email address provided upon entry, within one (1) day of the drawing. If a potential prize winner is notified by text, email or phone, he/she will be required to respond within (5) days or the prize will be forfeited and may be awarded to an alternate winner. Sponsor is not responsible for suspended or discontinued wireless or internet service which may result in a potential winner not receiving initial prize notification.
